NOTICE

It has been observed during the preliminary screening of applications for JKSET/LASET 2026 that some candidates, particularly those applying under the OBC category, have submitted invalid or incorrect reservation certificates.

All candidates are advised to ensure that their reservation certificates are valid and issued by the competent authority of the UT of Jammu & Kashmir or the UT of Ladakh, as applicable. Candidates who fail to submit a valid reservation certificate may have their candidature cancelled and may not be allowed to appear in the ensuing examination or may lead to disqualification.

Candidates whose certificates have been found invalid during the preliminary screening have already been informed through email or telephone. Such candidates are advised to submit a valid certificate within the prescribed time or, if eligible, opt for the General Category.

It has also been observed that some OBC candidates have submitted erstwhile WUP certificates of the UT of Jammu & Kashmir or OBC certificates issued by the Government of India. Such certificates are not valid for claiming reservation under the reservation rules applicable to the UT of Jammu & Kashmir.

Therefore, all OBC candidates are advised to submit a valid OBC reservation certificate issued by the competent authority under the applicable reservation rules of the UT of Jammu & Kashmir.

For the convenience of candidates, a sample of the valid OBC certificate applicable in the UT of Jammu & Kashmir is provided below.

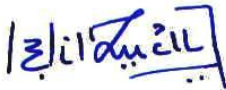
